Customers who spend a minimum of \$40 or more at any **specialty store** or a combination of specialty stores at Caboolture Square are eligible to receive a Free Gift – a Natio scented Candle 280g (Coast or Sunrise Scented), (valued at \$29.95) from Jadin Chemist OR a Cane Picnic Basket, (valued at \$34.00) from Discount Station.
2. Purchases/receipts from **Coles Supermarket and for prescription or scheduled medication, tobacco or tobacco related products, lotto and gambling transactions are excluded** from this offer.
