



Caboolture Square – The Giant Grocery Giveaway Competition Terms & Conditions

1. The competition commences on Wednesday 5 March. In-Centre entry closes at 10.30am on Wednesday 16 April. Online entry closes at 1.00pm on Wednesday 16 April.
2. Competition will be drawn at 2.00pm on Wednesday 17 April.
3. To be eligible to enter a customer must spend \$10 or more at any food, specialty store or service provider or \$60 at Coles, in one transaction on any one day.
4. Entry is either in-Centre with a printed Entry Form and receipt attached or online Entry Form with an upload of a Tax Invoice receipt from a Caboolture Square retailer dated during the competition period. Please note EFTPOS machine receipts will not be excepted as a valid entry.
5. Complete Entry Forms including a valid Tax Invoice receipt can be uploaded online or dropped into the entry box located at the competition display in-Centre.
6. Each entry upload is counted as one (1) entry and may not be used more than once.
7. Total Prize pool is valued at \$5,000.
8. The prize pool draw is as follows: 10 individual draws of 1 x \$500 Coles Gift Card. There are 10 winner's total.
