

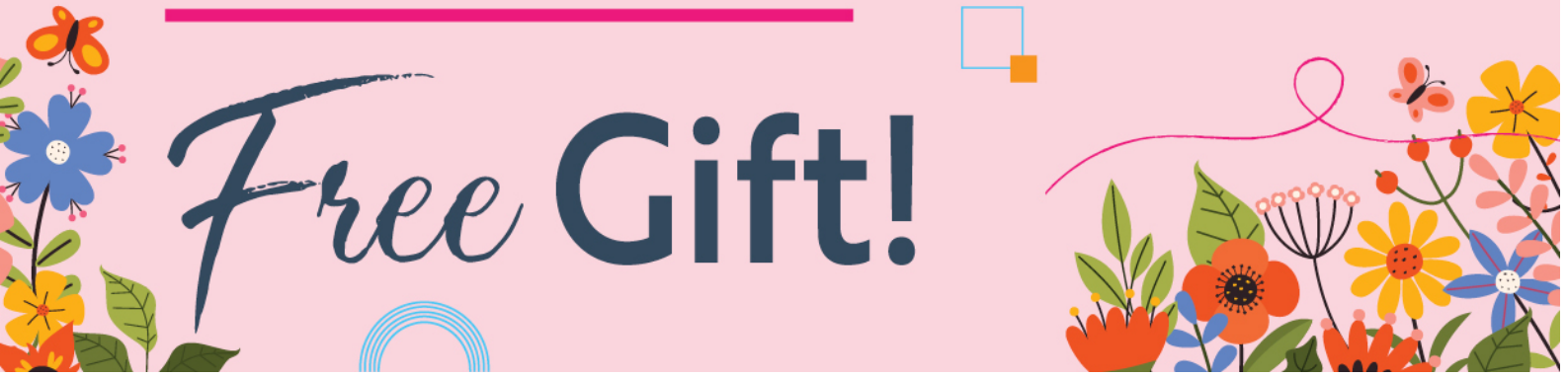
# Free Gift!
